Workers will be paid Weekly at \$18.71-\$23.00/hr, \$28.07-\$34.50/hr OT, Raise/bonus at employer's discretion with opportunity to earn more with experience. Applies fertilizer to lawns; may occasionally apply herbicides and pesticides when needed and directed by employers throughout the season. Employer provides weekly notes on what is needed any given week based on weather conditions. The employer will mix the mixtures and employee will apply as directed by the Employer each day. Post-Accident Drug Testing;Pre-hire background check required. All drug testing is performed without regard to an employee's citizenship or immigration status, and all testing is paid for by the company. All background checks are performed equally as to U.S. workers and H-2B workers, and all fees are paid for by the company. Able to lift 50lbs. No experience required, will train. Employer may make payroll deductions at employee's request. Employer facilitates voluntary housing arrangements upon worker request along with corresponding payroll deductions, \$75.00/week. A single workweek will be used to compute wages due. All deductions from the worker's paycheck required by law will be made. The employer will provide workers at no charge all tools, supplies and equipment required to perform the job. If the worker completes 50 percent of the work contract period, employer will reimburse the worker for initial transportation and subsistence costs from the place of recruitment to the place of employment for those traveling from such a distance they are not reasonably able to return to their residence each day. Upon completion of the work contract or where the worker is dismissed earlier, employer will provide or pay for worker's reasonable costs of return transportation and subsistence back home or to the place the worker originally departed to work, except where the worker will not return due to subsequent employment with another employer. **The amount of transportation payment or reimbursement will be equal to the most economical and reasonable common carrier for the distances involved. Daily subsistence will be provided at a rate of \$15.46 per day during travel to a maximum of \$59.00 per day with receipts.** H2B workers will be reimbursed in the first workweek for all visa, visa processing, border crossing, & other related fees, including those mandated by the government (excluding passport fees).
