Inland Lakes Rentals, Inc. d/b/a Rental Express located in Indian River, MI has openings for 4 full time temporary tent crew \$16.90 (\$25.35 O.T.) from 04/01/2024 to 10/31/2024. Set up, take down, delivery of rental tents, tables, chairs and retailated event equipment, load and unload delivery trucks with rental goods, maintenance and cleaning of rental goods. No exp. req. Must be able to bend, stoop and lift 100 pounds. The specific days and hours of work will vary depending on scheduling and the level of business but will generally be 5 days per week with rotating days off from 7:00 am to 6:00 pm approximately 40 hours per week with some overtime. The business is open 7 days per week. Weekend and holiday work will be required. The worksites will be at various customer locations in the immediate vicinity of the employer's location in Indian River. Customers, and hence the worksites, are spread across 5 counties: Cheboygan, Emmet, Charlevoix, Antrim, and Otsego. The workday starts and ends at the company's facility in in Indian River and transportation is provided by the company from that location to and from the day's worksites.

This posting is being made in connection with an application for H-2B workers.

Workers are paid every week. A single workweek will be used to compute wages due. The employer will make all deductions from the worker's paycheck required by law but will make no other deductions. Raises and bonuses available based on performance or length of service with the employer.

Work tools, supplies and equipment will be provided without charge or deposit.

If required by prevailing law the employer guarantees to offer work for hours equal to at least three-fourths of the workdays in each 12-week period of the total employment period. H-2B workers will be reimbursed in the first workweek for all visa, visa processing, border crossing, and other related fees, including those mandated by the government (excluding passport fees) incurred by the worker. If the worker completes 50% of the work contract period, employer will reimburse the worker for transportation and subsistence from the place of recruitment to the place of work. Upon completion of the work contract or where the worker is dismissed earlier, employer will provide or pay for worker's reasonable costs of return transportation and subsistence back home or to the place the worker originally departed to work, except where the worker will not return due to subsequent employment with another employer. The amount of transportation payment or reimbursement will be equal to the most economical and reasonable common carrier for the distances involved. Daily subsistence will be provided at a rate of \$15.46 per day during travel to a maximum of \$59.00 per day with receipts.

The employer does not provide housing or board during the term of employment however the employer may be able to assist in finding local housing for rent by the employee.

The workday starts and ends at the company's facility in Indian River and transportation is provided by the company to and from the day's worksites from that location but the employer does not provide any other local transportation during the term of employment.

This job order, including its wage and working terms and conditions, is contingent upon prevailing legal interpretations of federal H-2B immigration and FLSA employment law, including Department of Labor and Department of Homeland Security regulations. If any such prevailing law is rescinded, superseded, vacated, or substantially modified, then the employer will accordingly revise any affected term.
