The employer will make all deductions from the worker's paycheck required by law but will make no other deductions. Optional employer-offered housing in the backstretch at no cost to the worker. The employer will reimburse the H-2B worker in the first workweek for all visa, visa processing, border crossing, and other related fees, including those mandated by the government, incurred by the H-2B worker. If the worker completes 50% of the work contract period, employer will reimburse the worker for transportation and subsistence from the place of recruitment to the place of work.
