**Job Description**

Suburban Landscaping and Lawn Maintenance, located at PO Box 1145, Homewood, IL 60430, phone number: +1 (708) 799-6228, is seeking 15 temporary full-time snow cleaners to work at 1604 East End Ave., Homewood, IL 60430, from 12/01/2024, to 04/15/2025. Responsibilities include removing snow from sidewalks, driveways, or parking areas using snowplows, snow blowers, or snow shovels, and spreading snow-melting chemicals. Additional duties involve cleaning facilities or sites and gathering supplies and equipment used in cleaning and maintenance tasks.

**Job Requirements**

No prior education, training, or experience is required. On-the-job training will be provided. Candidates must be able to lift and carry up to 50 pounds, stand for prolonged periods, walk on slippery surfaces, navigate large areas and frequent bending, stooping, kneeling, pushing, and pulling heavy equipment. The role also involves climbing ladders, manual dexterity for handling tools, and operating machinery. Endurance for extended periods in various weather conditions, including cold and wet environments.

**Salary/Wages/Benefits**

\$18.43 an hour weekly, or approximately 35 hours per week, from Monday to Friday from 7:30 a.m. to 5:00 p.m. Up to 10 hours of overtime may be available but not guaranteed; \$27.65/hr for overtime. Applicants may be offered more than advertised. The wage rate may vary based on experience and/or merit. All deductions from the worker's paycheck will be made as required by law. The employer will use a single workweek as its standard for computing wages and pay biweekly by check. Any advances will be deducted with the consent of the employee. Optional daily transportation will be provided from and to the worksite.

In the first workweek, the cost of transportation to the place of employment will be directly reimbursed to every worker. If the worker completes 50 percent of the work contract period, the employer will reimburse the worker for transportation and subsistence from the place of recruitment to the place of work. Upon completion of the work contract or where the worker is dismissed earlier, the employer will provide or pay for the worker's reasonable costs of return transportation and subsistence back home or to the place the worker originally departed to work, except where the worker will not return due to subsequent employment with another employer or where the employer has appropriately reported a worker's voluntary abandonment of employment. The amount of transportation payment or reimbursement will be equal to the most economical and reasonable common carrier for the distances involved. In the first workweek, daily subsistence for travel to the place of employment will be reimbursed at a rate of at least

\$15.88/day to a maximum of \$59.00/day with receipts. Also, workers will be reimbursed in the first workweek for all visas, visa processing, border crossing, and other related fees, including those mandated by the government (except passport fees). The employer will provide workers without charge or deposit charge for all tools, supplies, and equipment required to perform the job.
