## Job Duties and Skills:

Description: Westward Seafoods, Inc. is looking to fill approximately 490 Seafood Processor positions at its plants in Unalaska. These are temporary, FT positions and with employment from 12/29/2024 to

04/30/2025. Westward Seafoods, Inc. is located at 3015 112<sup>th</sup> Ave. NW, Suite 100, Bellevue, WA 98004; Phone: (206) 682-5949.

**Job Duties:** will process crab, multiple species of finfish, bottom fish and salmon. Work on the hand butcher line will involve use of hands and hand tools to perform routine cutting and trimming. Workers will wash, size, and grade seafood and then load processed seafood onto freezer baskets or cartons for shipping. Employer is offering at least 40 hours/week at \$16.85/hr. Mon-Sun, 6:00AM - 6:00PM or 6:00PM - 6:00 AM (daily/shift schedule varies). Employer is offering up to 44 hours of overtime per week available, as needed, but not guaranteed. Overtime will be paid at a rate of \$25.28/hr. Overtime is paid for working greater than 8 hours in any given day, or greater than 40 hours in any given week. Employer reserves the right to pay a higher wage rate or bonus to any worker in their sole discretion based on performance, skill, tenure, or experience. Up to the first three weeks of employment will include paid on the job training. Workers must be able to work long period of time on their feet, cold, wet environment. Must be at least 18 years old.

**Job Requirements:** No minimum education, training, or experience required. Pre-employment drug test will be required at the employers expense.

**Transportation:** If the worker completes 50% of the work contract period, the employer will reimburse the worker for transportation and subsistence from the place of recruitment to the place of work. Upon completion of the work contract or where the worker is dismissed earlier, the employer will provide or pay for worker's reasonable costs of return transportation and subsistence back home or to the place the worker originally departed to work, except where the worker will not return due to subsequent employment with another employer or where the employer has appropriately reported a worker's voluntary abandonment of employment. The amount of transportation payment or reimbursement will be equal to the most economical and reasonable common carrier for the distances involved. Daily subsistence will be provided at a rate of \$15.88 per day during travel to a maximum of \$59.00 per day with receipts. The employer will provide transportation to and from worksite at no cost to workers.

**Tools, supplies and equipment:** Employer will provide workers at no charge all tools, supplies, and equipment required to perform the job.

**Other Employment Guarantees:** A single workweek will be used for computing wages due and workers will be paid every 2 weeks. The employer will make all payroll deductions required by law and will not make any deductions, which are not required by law. H-2B workers will be reimbursed in the first workweek for all visa, visa processing, border crossing and other related fees including those mandated by the government (excluding passport fees), incurred by the H-2B worker.

**Housing:** Optional employer-provided housing is available for \$15/day-\$25/day based on Alaska State guidelines.
