Upon completion of the work contract or where the worker is dismissed early, employer will provide or pay for the worker's reasonable costs of return transportation and daily subsistence back home or to the place the worker originally departed to work, except where the worker will not return due to the subsequent employment with another employer. The amount of transportation payment or reimbursement will be equal to the most economical and reasonable common carrier for the distances involved. Daily subsistence will be provided at a rate of \$15.88 per day during travel to a maximum of \$59.00 per day with receipts.**
- 19. Employer will pay for the worker's cost of return transportation and daily subsistence from the place of employment to the place from which the worker, disregarding intervening employment, departed to work for the employer, if the worker completes the certified period of employment or is dismissed from employment for any reason by the employer before the end of the period, as is also outlined above.**
- 20. Employer will only provide daily transportation to/from the worksite from/to the employer-provided housing, if housing is not within walking distance.**
- 21. Employer will reimburse H-2B worker in the first work week for all visa, visa processing, border crossing, and other related fees, including those mandated by the government incurred by the H-2B worker via check issued to employee (but need not include passport expenses or other charges primarily for the benefit of the worker)**
