Line Cook

IP Casino Resort Spa, 850 Bayview Avenue, Biloxi, MS 39530, seeks to hire 5 temporary, full time workers for the position of Line Cook from 12/25/2024 to 10/13/2025 in Biloxi, MS. Will perform general duties required by Line Cook: Receive and prepare food orders according to memorized standard recipes. Coordinate orders for pick-up. Maintain cleanliness of workstation and storage areas at all times. Control waste by monitoring proper rotation, storage, and quality control. Maintain inventory of station and order stock to maintain pars. Consistently apply established safety and sanitation procedures. Must have minimum of six months of experience as a cook. Must be able to stand and/or walk for duration of shift. Must be able to lift, carry, and maneuver up to 75 pounds.

On-the-job training will be during the first 5 days. Employee will be provided 2 days of company orientation.

Workers scheduled for one shift per day between the hours 8am-3am, Monday-Friday and one shift per 24 hrs Saturday and Sunday with 1-2 days off per week at the hourly rate of \$14.43 or more based on experience. Employees are paid in biweekly pay periods. Paid holiday pay after 90 days of employment.

Each temporary employee to be employed as a Line Cook may have to work overtime to ensure the project is complete on time. Overtime is paid at \$21.65/hour. Single workweek used to compute wages.

Employees will be provided 1 hour paid break.

Criminal background check (post hire, pre-employment).

Employer will reimburse H-2B workers in the first work week for all visa, visa processing, border crossing, and other related fees, including those mandated by the government, incurred by the H-2B worker (excluding passport expenses and other charges that primarily benefit the worker).

Employer will provide return transportation and daily subsistence if the worker completes the employment period or is dismissed early. Employer will provide at no charge, all tools, equipment and supplies necessary to perform the job.

The employer guarantees to offer work for hours equal to at least three-fourths of the workdays in each 12-week period of the total employment period. Employer will make all the deductions from paychecks that are required by law. All deductions will be FLSA-compliant.
