Description:

1) Beautiful Country Landscapes is located at 5300 Riggs Road, Suite G, Gaithersburg, MD 20882, p301-704-8309, email: beautifulcountrysllc@gmail.com.

2) 13 Landscape Laborers are needed for temporary, full-time employment.

3) Thirteen (13) positions available for temporary full-time Landscape Laborers to begin working March 18, 2025 and continue through November 18, 2025, with 40 hours work provided weekly at day shift 8am to 4pm Monday through Friday at \$20.55 or higher per hour, with overtime offered regularly at \$30.83 or higher per hour. No education or prior experience or training are required, including no on-the-job training needed, as clear and simple instructions are provided on the worksite by a supervisor.

Landscape Laborers prune and trim shrubs, hedges, plants, and trees at ground-level. Landscape Laborers also rake, dig, water, plant, and weed. Landscape Laborers mow and mulch and chip. Landscape Laborers collect and haul out fallen branches and other debris, and also load and unload our crew vehicles.

4) The geographic area of this job is Gaithersburg, Maryland from which we leave daily for worksites in different towns of Montgomery County and Prince Georges County and returning home the same day.

5) Pay is \$20.55 or higher per hour.

6) Optional overtime is offered regularly at \$30.83 or higher per hour.

7) No on-the-job training necessary. Supervision and guidance are provided to Landscape Laborers directly on the job by skilled Crew Managers. Landscape Laborers do not supervise any staff.

8) Beautiful Country Landscapes uses a single workweek as its standard for computing wages due.

9) Employees will be paid each week on Friday. Payment is unconditionally free and clear.

10) Beautiful Country Landscapes does not provide housing.

11) Beautiful Country Landscapes will make all paycheck deductions required by law and only deductions required by law, such as income tax and social security; No other deductions are made from the worker's paycheck.

12) Beautiful Country Landscapes will reimburse workers who complete 50 percent of the work period covered by this job order the cost of transportation and daily subsistence and lodging from the place which the worker has come to work for the employer, whether in the U.S. or abroad to the place of employment, consistent with 20 CFR 655.20(j)(1)(i).

13) Beautiful Country Landscapes will also provide or pay for the worker's cost of return transportation and daily subsistence from the place of employment to the place from which the worker, disregarding intervening employment, departed to work for the employer if the worker completes the certified employment period or is dismissed for any reason by the employer before the employment period ends, consistent with 20 CFR 655.20(j)(1)(ii).

And where a worker must travel to obtain a visa so that the worker may enter the USA to come to work for Beautiful Country Landscapes, the employer will pay for the transportation and subsistence costs of that part of travel too. The amount of transportation reimbursement will be equal to the most economical and reasonable common carrier for the distances involved. The amount of money that the worker will receive for daily subsistence will be at least \$15.88 per day during travel to a maximum of \$59.00 per day with receipts.

14) Beautiful Country Landscapes provides daily transportation to worksites. Our work crews leave from our Gaithersburg headquarters for worksites each day. If a worker cannot get to the headquarters, he/she can be picked up at home by the work crew, and returned home the same day. No other travel is required.

15) Employees will be reimbursed in the first workweek for all visa, visa processing, border crossing, and other related fees, including those mandated by the government (except passport fees) incurred by the H-2B employee.

16) Beautiful Country Landscapes will provide workers, at no charge or deposit, all tools, supplies, and equipment required to perform the job duties assigned, in accordance with 20 CFR 655.20(k).
